Obligation of Information in Accordance with the REACH Regulation (EG Nr. 1907 / 2006)

Dear Sirs,

On 1 June 2007, the new EU Regulation REACH (Registration, Evaluation, Authorisation and Restriction of Chemicals) came into force. This regulation has significant impacts on all actors in the supply chain. Our company produces "goods", i.e. Standard Parts, Workholding Systems, Hand Tools and Aviation Products). As a manufacturer according to REACH, we are so-called "downstream user".

For our company, any duties resulting from the manufacture and placing on the market of substances / chemicals for the pre-registration and/or registration with ECHA do not apply. For this reason, our products cannot be defined as a substance and/or a preparation. In addition, no substance is released from our products under normal conditions and under conditions of use. As a result of this, we are neither subject to registration nor to the production of any safety data sheets.

We therefore have the obligation to inform our customers in accordance with REACH Article 33 provided that a substance of very high concern (SVHC) with a content of more than 0.1 % by mass is in one of our supplied products. The list of the SVHC substances is continuously updated and published on the website of the European Chemicals Agency (ECHA) at <http://echa.europa.eu>.

In our own interests and against the background of a high delivery reliability and product safety, we ourselves take the obligation to provide information very seriously.

The EU suppliers of goods that are included in our own products to a relevant extent are obliged to inform us unsolicited and without delay if a SVHC substance exceeding 0.1 weight percent is in one of their supplied goods. Should we receive that information and come to the conclusion that the threshold value of 0.1 percent by weight of a SVHC substance is exceeded in one of our own products, we will inform you immediately.

Based on our suppliers' information, our products do not contain any SVHC substance in a mass concentration over 0.1 %.

Exception:

In June 2018, lead (Pb – CAS number 7439-92-1) was added to the SVHC list. In the steel, aluminium and copper materials we use, you can partly find lead used as an alloying element. As lead in its function as an alloying element is chemically bound, these products do not pose a danger under normal conditions of use.
